The Littleton Elementary School District is dedicated to the recruitment, training and continuous development of school psychologists and follows the Professional Standards of the National Association of School Psychologists (NASP) to support the continuous growth of our psychologist team. School Psychologist Intern supervisors will provide weekly informal performance feedback, monthly review of performance and internship requirements, and written evaluation of performance that includes recognition of strengths, targets for growth and plans to facilitate growth. Progress towards NASP and/or University Internship requirements will be monitored throughout the internship by both the intern and the intern supervisor. At the end of the School Psychology Internships, it is our intention that interns will gain the experiences necessary to present with the competencies needed for independent practice within the school setting.
